### Terms of Membership:

(b) A member may resign from TRESOR DAY SPA prior to the end of the agreement if member provides TRESOR DAY SPA with a minimum of **30 days' written notice**. **In the event a 30-day written notice is not given, or the membership is cancelled within the first 3 months of beginning the membership, you will be required to reimburse the spa for the difference in the price of services ALREADY performed in that first 90 days between the regular price and membership price. If you wish to stop the membership immediately, an early cancellation Fee of \$50 will be charged to the Member's credit card on file.** Notices must be received before the end of the business day on the 10th of the month and will take effect on the first day of the month following the expiration of the notice period. **Prior to the effective date of termination, the member shall be responsible for the payment of all fees, dues, and charges due to TRESOR DAY SPA.**

(c) Member Obligation: Failure to use the facilities will not relieve the Member of the obligation to pay the monthly dues during the initial 12 month term or any monthly renewal term of the membership. If for any reason, my bank or credit card does not honor any membership draft, I understand that I am responsible for said payment plus penalty fee payable to TRESOR DAY SPA (currently \$30.00). This will be in addition to any bank service charge fee(s).

- b. Failure to pay dues or charges when due, or returned check or credit card payments.

2. Member certifies that he or she is in good physical health and is able to have facials and massage therapy.

3. The member agrees to pay all membership fees on said due date in accordance with this Agreement. If a member should fail to pay any amounts payable to TRESOR DAY SPA when due, then the unpaid balance will be assessed an interest charge at the rate of 1.50% per month until paid plus any penalty TRESOR DAY SPA imposes for nonpayment. Should collection efforts be required, the member shall be fully responsible for payment of all costs of collection, including reasonable attorney fees.

4. The member understands that Tresor Day Spa reserves the right to implement minimal price increases upon adequate notice to member.
